

FOUNDATION, WALL, & SLAB NOTES

- TOP OF SLAB ELEVATION IS NOTED WITH BENCH MARKS RELATIVE TO THE FINISHED FIRST FLOOR ELEVATION (0'-0" INTERIOR FINISH). TOP OF ALL FOOTINGS SHALL BE AT ELEVATION INDICATED THIS: () ON PLANS, AND ARE RELATIVE TO THE FINISHED FIRST FLOOR ELEVATION. AN EXCEPTION CAN OCCUR WHERE FIELD CONDITIONS REQUIRE AN ADJUSTMENT.
- FOUNDATIONS HAVE BEEN DESIGNED FOR AN ALLOWABLE BEARING CAPACITY OF 2000 PSF. THE CONTRACTOR SHALL ALLOW THE PROJECT GEOTECHNICAL ENGINEER TO VERIFY SOIL CONDITIONS PRIOR TO PLACING FOUNDATIONS.

- GROUT FOR FILLING BLOCK CORES SHALL CONFORM TO ASTM C416, COARSE GROUT, WITH A MINIMUM COMPRESSIVE STRENGTH OF 3000 PSI @ 28 DAYS. GROUT SHALL BE PLACED IN LIFTS NOT EXCEEDING 8 FEET IN HEIGHT.
- ALL MASONRY WALLS SHALL BE LAID IN RUNNING BOND, EXCEPT WHERE NOTED. ALL MORTAR JOINTS ARE TO BE HALF ROUND SCOURED. MASONRY IS TO BE EXPOSED.

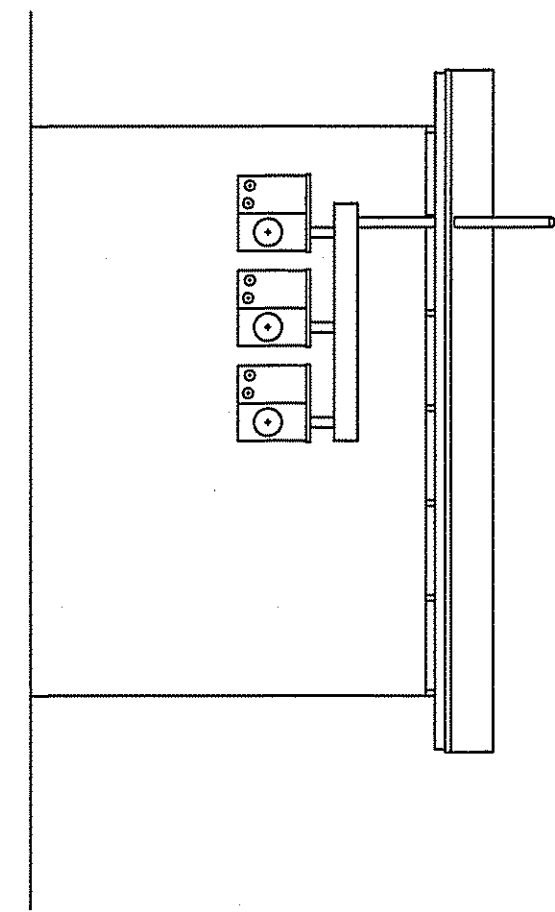
FOOTING PLAN

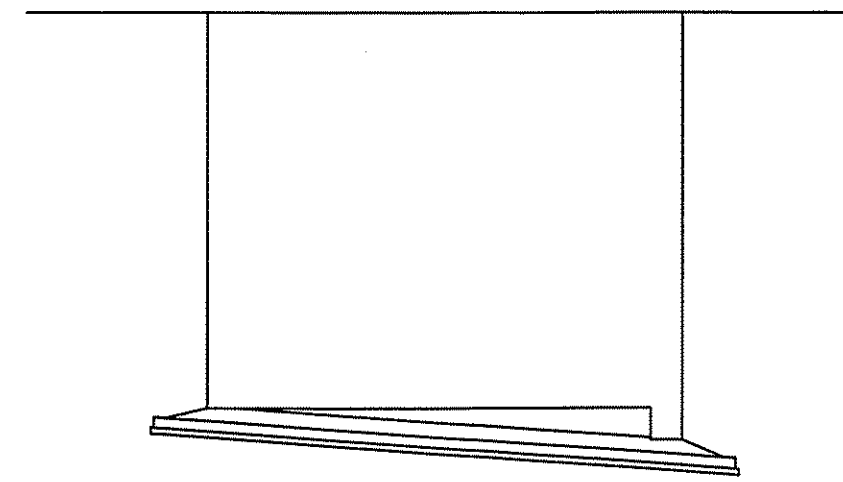


WEST ELEVATION - UTILITY

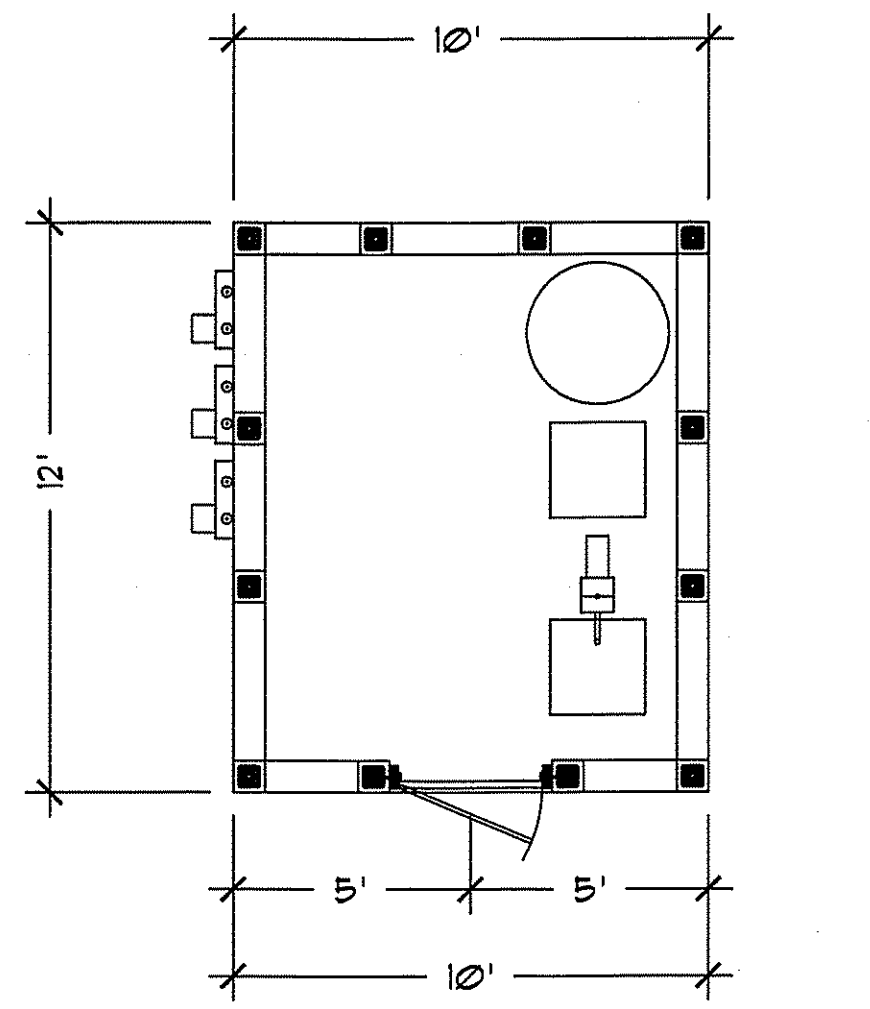
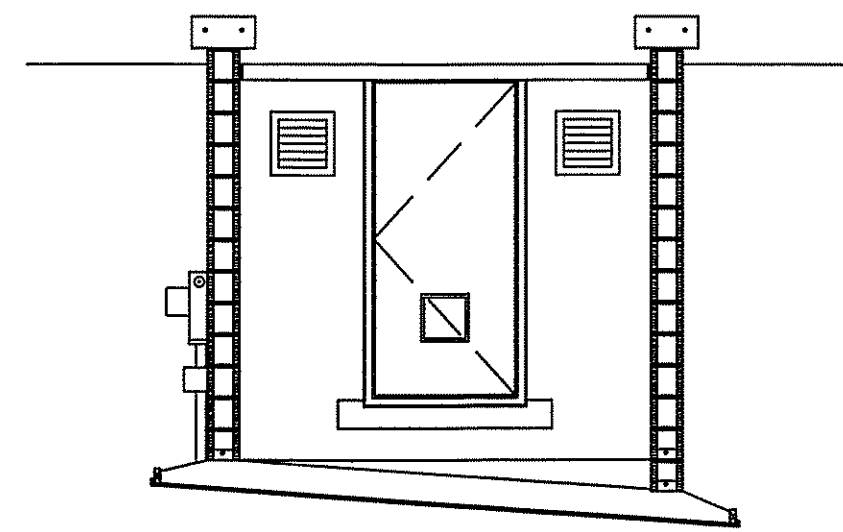


EAST ELEVATION - UTILITY

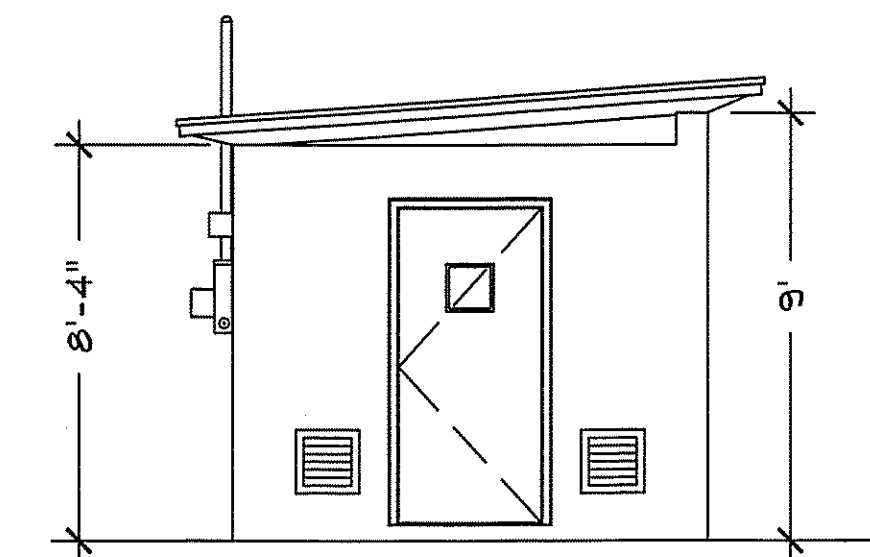

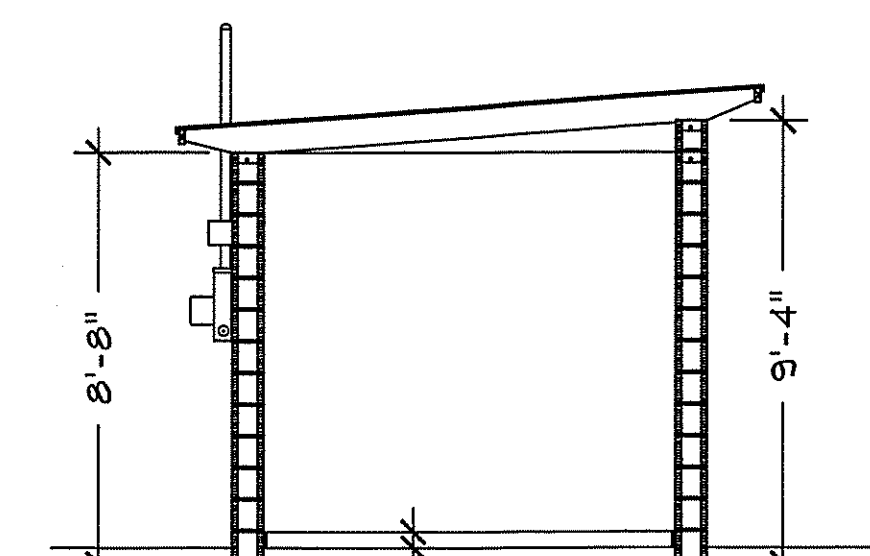
E-W SECT LOOKING SOUTH

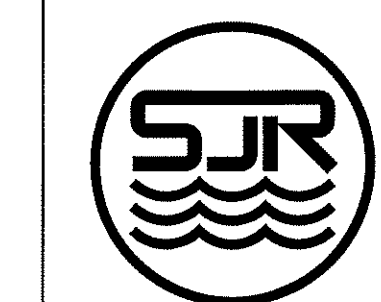
FLOOR PLAN

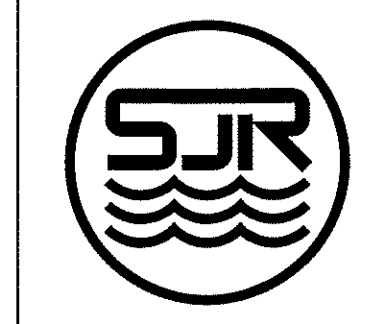
